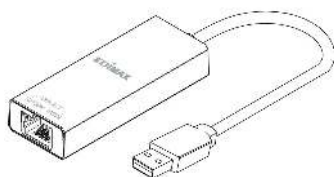

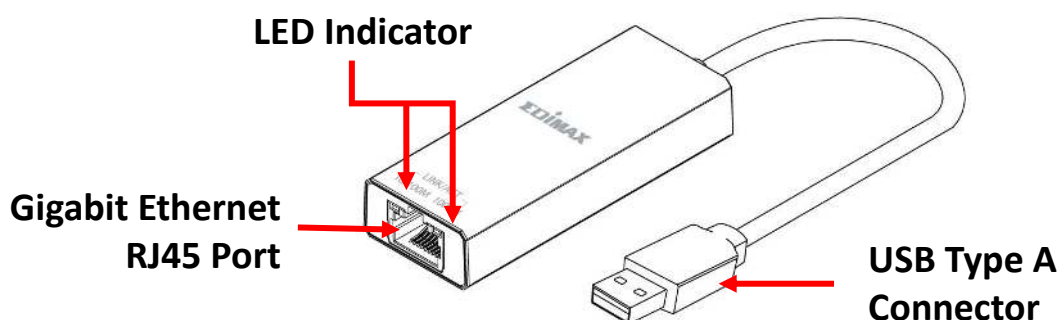

II-1. Insert the Adapter

Insert the adapter into the USB Type-A port on your computer.



Please wait for 10 seconds after plugging in.



Never use force to insert the adapter. USB 3.2 port is recommended for the best performance.

II-2. Connect to the Network

Plug the RJ45 Ethernet cable to the adapter, if the Plug-and-Play is supported “Network connected”  icon will be displayed on the Windows taskbar. The network connection is ready.



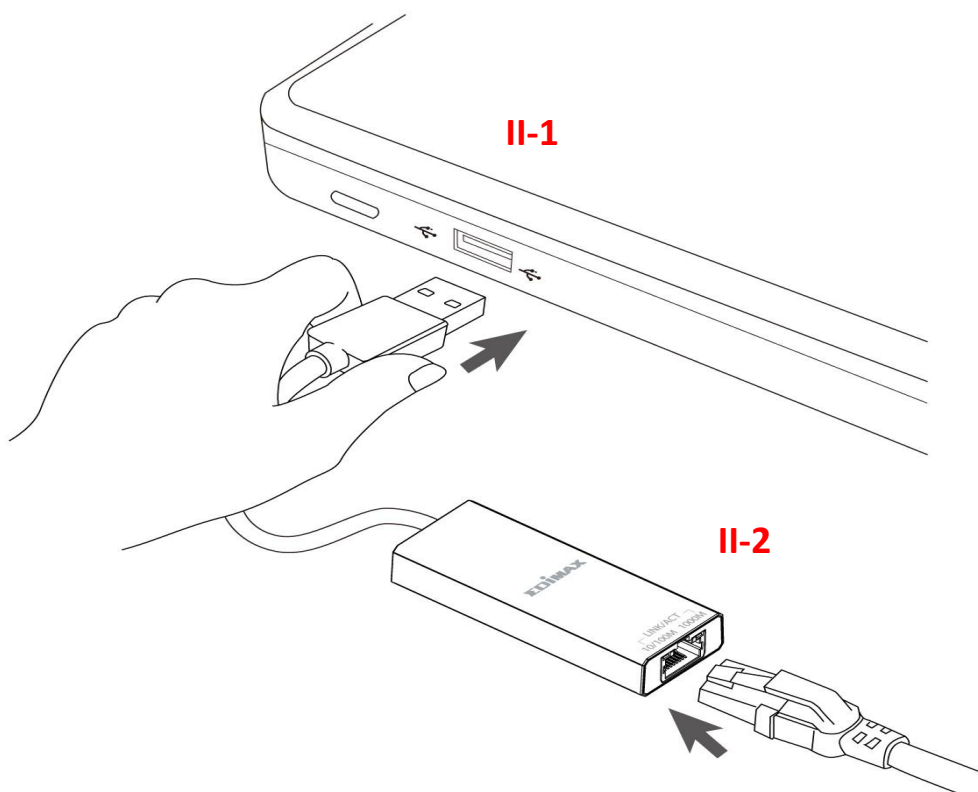

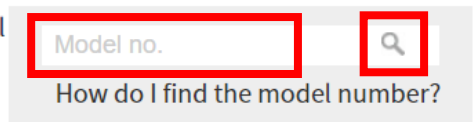

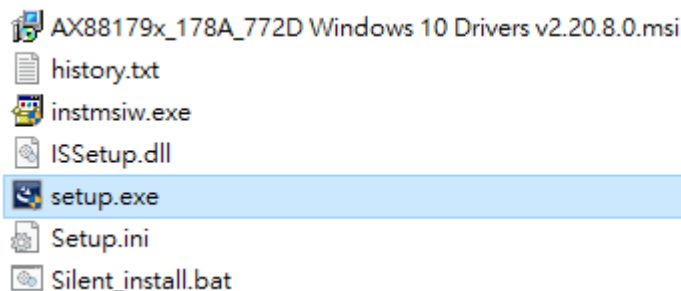


3. Click on the model number on the search result.
4. Scroll down the web page and select the right OS version. Move the cursor to the “**Download icon**”  and save the driver on the computer desktop or a location you prefer.



Copy the driver to the USB flash drive first if you downloaded the driver on another Internet-Enabled device and insert the USB flash drive to the computer that you will be using the adapter on.

5. Move the cursor to the driver and extract the file. Once it's uncompressed fully, access the folder and click the **setup.exe** to continue.



6. Follow the instruction to complete the installation.
7. Please make sure your computer has been restarted before you go to next step.

III-3. Connect to the Network

1. After you restarted your computer, insert the adapter into the USB Type-A port on your device.
2. Plug the RJ45 Ethernet cable into the RJ45 LAN port, the “**Network connected**”  icon will be displayed on the bottom-right corner of the Windows taskbar. The network connection is ready.

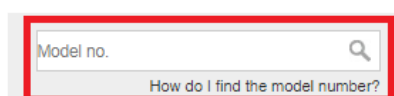
